

## **COVID-19 Release of Liability**

The World Health Organization declared COVID-19 a worldwide pandemic. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Way of Wisdom Homeschool Group LLC has put in place protective measures to reduce the spread of COVID-19 in accordance with Governor Gretchen Whitmer's executive orders and health guidelines from the Centers for Disease Control and Prevention ("CDC"), the State of Michigan, and County Health Departments. These measures include the following (collectively, "Protective Measures"):

- requiring proper physical distancing when possible
- requiring masks in hallways and common areas for those able to medically tolerate a mask and without a medical exemption/waiver;
- promptly removing anyone who might be displaying symptoms of COVID-19
- ensuring students, employees, and volunteers have requisite information and/or training on policies and procedures that have been implemented to curb the spread of COVID-19
- regular sanitization and cleaning
- providing personal protective equipment and disinfecting supplies/soap to students

Even following the above precautions, Way of Wisdom Homeschool Group LLC cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending activities on the campuses of Way of Wisdom Homeschool Group LLC could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I agree that myself, my child(ren), my spouse/co-parent of child(ren) (collectively, "I," or "me") agree to follow the Protective Measures implemented by Way of Wisdom Homeschool Group to reduce the spread of COVID-19. These Protective Measures may be amended from time to time, by Way of Wisdom Homeschool Group in its sole discretion and/or based on mandates and/or recommendations from the CDC, the State of Michigan, and the County Health Departments. By signing this agreement, I understand there may be changes to the Protective Measures at which time I reserve the right to either comply with the changes or complete the course online only.

I acknowledge the contagious nature of COVID-19 and on behalf of myself, my child(ren), my and spouse/co-parent of child(ren) voluntarily assume the risk that my child(ren) and I, and any member of my family, may be exposed to or infected by COVID-19 by attending activities on the WOW campuses and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 while on WOW campuses may result from the actions, omissions, or negligence of myself and others, including, but not limited to, the WOW employees, agents and representatives, volunteers, program participants and their families and/or any other individual who may be present upon school property or in attendance at any school activity.

I voluntarily agree to assume, on behalf of myself, my child(ren), and my spouse/co-parent of child(ren) all risks and accept sole responsibility for any injury to my child(ren), myself and any member of my family, (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I, my child(ren) and/or members of my family may experience or incur in connection with my child(ren)'s attendance in activities or participation in Way of Wisdom Homeschool Group programming ("Claims").

I, on behalf of my child(ren) and our heirs, assigns, personal representatives, and next of kin, hereby release and hold harmless Way of Wisdom Homeschool Group LLC, its officers, officials, agents, employees, volunteers, other participants, affiliated organizations (including Oxford Virtual Academy and Oxford Public Schools), sponsoring agencies, and if applicable, owners and lessors of premises used to conduct activities, with respect to any and all illness, disability, or death, to the fullest extent as permitted by law.
